
ONEIDA COUNTY LOCAL DEVELOPMENT CORPORATION NOTICE OF PUBLIC HEARING ON PROPOSED ISSUANCE OF BONDS

NOTICE IS HEREBY GIVEN that a public hearing pursuant to Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code") will be held by the Oneida County Local Development Corporation (the "Issuer") on the 12th day of October 2017 at 9:00 a.m. local time, at the offices of the Issuer, 584 Phoenix Drive, Rome, 13441 New York in connection with the following matters:

Upstate Cerebral Palsy, Inc., a New York not-for-profit corporation (the "Company"), has requested that the Issuer consider issuing its Revenue Refunding Bonds (Upstate Cerebral Palsy, Inc. Project) in the aggregate principal amount not to exceed \$3,000,000 (the "Series 2017 Bonds") to finance a project (the "Project") for the benefit of the Company consisting of (A) the refunding of the outstanding principal amount of the Oneida County Industrial Development Agency ("OCIDA") Civic Facility Revenue Bonds (Mohawk Valley Handicapped Services, Inc. Project), Series 2005 (the "Series 2005 Bonds") issued for the benefit of Mohawk Valley Handicap Services, Inc. and the Company, the proceeds of which were used to finance (1)(i) the acquisition of an approximately 7.3 acre parcel of land located at 130 Brookley Road in the Griffis Business and Technology Park, City of Rome, Oneida County (the "Land") (ii) the construction on the Land of an approximately 29,000 square foot building and four 6-bed residential houses (the "Facility") and (iii) the acquisition and installation in the Facility of certain furniture, machinery and equipment (the "Equipment") (the Land, the Facility and the Equipment are collectively referred to as the "Project Facility"), (2) the payment of a portion of the cost incidental to the financing thereof all for the purpose of providing day care services and educational services for children, and (B) paying certain costs and expenses incidental to the issuance of the Series 2017 Bonds.

The Project Facility will be owned by the Company. The Issuer and the Company will enter into a financing agreement (the "Agreement") requiring that the Company make payments equal to the debt service on the Series 2017 Bonds and make certain other payments.

The Series 2017 Bonds will be a special obligation of the Issuer payable solely from payments made by the Company under the Agreement. THE SERIES 2017 BONDS SHALL NOT BE A DEBT OF THE STATE OF NEW YORK OR ANY POLITICAL SUBDIVISION THEREOF, INCLUDING, WITHOUT LIMITATION, THE COUNTY OF ONEIDA AND NEITHER THE STATE OF NEW YORK NOR ANY POLITICAL SUBDIVISION THEREOF, INCLUDING, WITHOUT LIMITATION, THE COUNTY OF ONEIDA, SHALL BE LIABLE THEREON.

In addition to the issuance of the Series 2017 Bonds, the Issuer may provide financial assistance to the Company in the form of exemption from mortgage recording taxes.

A representative of the Issuer will, at the above-stated time and place, hear and accept written comments from all persons with views in favor of or opposed to either the issuance of the Series 2017 Bonds, the proposed owner or the location of the Project Facility or the nature of the Project.

The application for financial assistance filed by the Company with the Issuer, including an analysis of the costs and benefits of the proposed Project, is available for public inspection at the offices of the Issuer located at 584 Phoenix Drive, Rome, New York.

Minutes of the hearing will be made available to the County Executive of Oneida County. Approval of the issuance of the Series 2017 Bonds by Oneida County through the County Executive is necessary in order for the interest on the Series 2017 Bonds to be excluded from gross income for federal income tax purposes.
